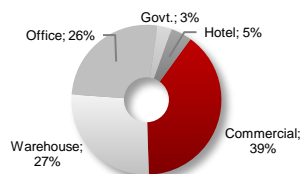

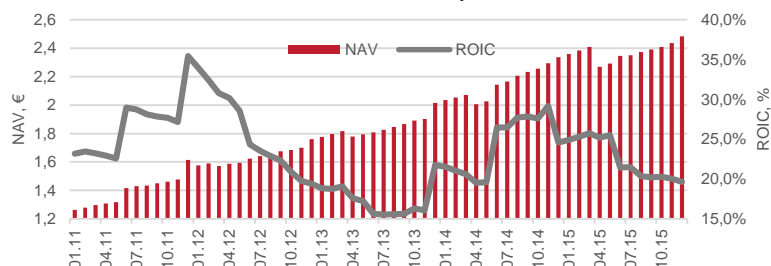

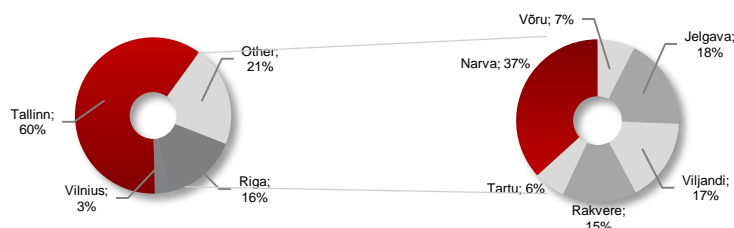

Investments by region



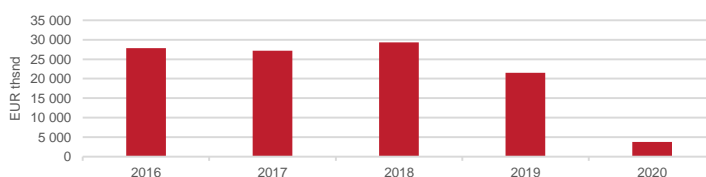
